Stevenson Major Groups

Most of the Stevenson's listed on the Chickasaw and Choctaw Freedmen Rolls are descendants from one of three (3) major Stevenson Groups: Mobile Stevenson, Steven Stevenson and Mack James Stevenson

I have not been able to determine the relationship between Mobile, Mack and Steven. They may be brothers but I have found no evidence to support this claim. However, my family oral history (per Adam "Joe" Stevenson) has it that there were two (related/unrelated???) branches of the STEVENSONs.

Each branch resided on one side or the other of Arbuckle Mountain and did not maintain contact due to a family "rift". There are some (living) family members (Henry Shannon et al) who had family on each side of the rift/mountain and visited on both sides of the mountain as a child. He knows that there was some family rift and that the families did not maintain contact; but he was not privy to the cause of the rift. Nevertheless, I believe that 3 major groups are related. Interestingly enough, these groups all decided to take the surname Stevenson.

Each major group has their own descendant report document. The following descendant report is for Mack Stevenson. The first generation of this descendant report shows the parents of Mack Stevenson, Hardy JAMES and Greasy COLBERT. It also lists his brothers July and Phillip.

Mack James Stevenson

Mack Stevenson was active in Chickasaw Freedmen affairs and represented the Freedmen of Pickens County (Woodward Post Office). He was considered to be one of the leading men amongst the Chickasaw Freedmen. He was a member of the Chickasaw Freedmen's Association. He was also elected, by the freedmen, to serve on a committee to assist the Dawes Commission in identifying freemen eligible for enrollment.

"In September 1887, Mack was member of the committee representing the Freedmen of the Chickasaw Nation. The committee representatives were: W. N. Jackson, Wash Taylor and Sam Cheadle of Tishomingo County; Phillip Stephenson, Mack Stephenson, and Dick Roberts of Pickens County; Isham Love, Caleb Love, and Abram Eastman of Panola County; Jack Alexander, Wilson Chico (or Sheco), and Lee Kemp of Pontotoc County; Henry Kemp of the Stringtown settlement of Chickasaw freedmen in the Choctaw Nation; and T. J. Humphries of the Caddo settlement in the Choctaw Nation. The committee represented some two or three thousand freedmen."

On September 14, 1887 the committee met with Union Agent Robert L. Owens and "reported that their people were doing "tolerably well" with their farming and stock raising, that the Chickasaws treated them well, that they were without schools, that they would like to be adopted by the Chickasaws, and that although they were willing to remove in 1866, since then they had grown attached to the land they famed and wished to remain unless the government thought it best that they go."

“Owen told them that he would report their resolutions and offered his services to them. After private consultation, the committee handed Owen their decision, written as follows: “The hole Number of men has A Greed to be left in the hand of the united State if the Chickasaw do Not take us.” Before leaving, they gave Owen the names and post offices of their leading men: Isham Love (Colbert), W. N. Jackson (Washita Settlement), Isham Flint (Mill Creek), Cap H. Harper (Cherokee Town), Isham Alexander (Johnsonville), King Blue (Stonewall), Wilson Chico and Lee Kemp (Tishomingo), Jim Williams (Fort Arbuckle), Mack Stephenson (Woodward), Si Love (Burneyville), Charles Cohee (Dresden), Henry Kemp (Stringtown, Choctaw Nation), and T. J. Humphries (Caddo, Choctaw Nation).”

On October 15, 1894 the freedmen met in convention and entered formal contracts with Mullen and Belt, who were to seek provisions for allotments for the freemen or, failing that, to secure land for them elsewhere. They were also to seek legislation for the payment of damages sustained by the freemen as a result of the long delay in carrying out the treaty stipulations and of the denial of educational privileges and titles to their land. The attorneys presented to the secretary of the interior an appeal that set forth the freemen’s claims and status. At the secretary’s suggestion the Committee of the Chickasaw Freedmen’s Association – Charles Cohee, Isaac C. Kemp, George W. Hall, and Mack Stevenson – presented a statement of their grievances through Belt and Mullen to the Dawes Commission. After reviewing the Treaty of 1866 and the failure by both the Chickasaw and the government to fulfill its stipulations, the freedmen pointed out that they had no role in negotiating the treaty and insisted, therefore, that the United States was duty bound to look after their interests. The committee also noted their attempts to obtain justice and congressional failure to act.”

In August 1896, “The Dawes Commission had asked the freedmen to select a committee of reliable men to assist in identifying freemen eligible for enrollment. The freedmen’s convention elected Cohee, Mack Stevenson, Henry Gaines, Soloman McGilbry, and Samuel Jones to attend the Dawes Commission during the enrollment of the Chickasaw freedmen and to assist the freedmen and the attorneys in placing the eligible freemen’s names on the official roll. To defray expenses, the committee of freedmen was to receive fifty cents from each head of family who appeared before the commission. Cohee, Lee Newberry, and Nelson Eastman were charged with obtaining tents and camping outfits necessary for setting up mobile enrolling stations. And the convention directed the chairman of each subordinate association of the Chickasaw Freedmen’s Association to obtain the names of orphan freedmen and those freedmen in prison and to secure legal guardians for orphans, idiots, and the insane.”

The children of Mack STEVENSON and Elsie STEVENSON are: Hardy STEVENSON, Robert STEVENSON, Adge STEVENSON, Rena STEVENSON, Etta STEVENSON, Ella STEVENSON and Allen STEVENSON.

Initially, Mack had the surname JAMES. He changed it to STEVENSON, which he took from his wife Elsie.
